A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FIRST OPTION TO EXTEND THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SAN DIEGO AND THE SAN DIEGO HOUSING COMMISSION FOR THE TEMPORARY BRIDGE SHELTER PROGRAMS, AND TAKING RELATED ACTIONS.

WHEREAS, the San Diego Housing Commission (Housing Commission) administers the agreements for the City of San Diego's (City) Homeless Shelters and Services Programs based on a Memorandum of Understanding (MOU) between the Housing Commission and the City that first took effect on July 1, 2010; and

WHEREAS, the Housing Commission and City entered into a separate MOU for the Provision of Temporary Bridge Shelters, which was approved by the Housing Commission Board of Commissioners on November 3, 2017, as well as the Housing Authority and San Diego City Council (City Council) on November 14, 2017 for an initial term ending June 30, 2018 with options to extend the MOU; and

WHEREAS, staff recommends approving the first option to extend the MOU to allow for continued for oversight and administration of the Temporary Bridge Shelters; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego that it approves the

first option to extend the MOU between the Housing Commission and the City for the Provision of Temporary Bridge Shelters for a one-year term, from July 1, 2018 through June 30, 2019.

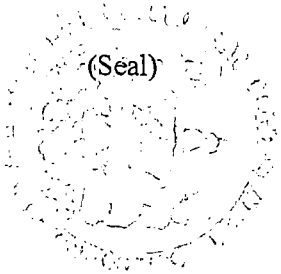
