DATE OF FINAL PASSAGE JUN 21 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO ENTER INTO A MARKETING AGREEMENT WITH AEROMETALS INC. IN ORDER TO ACCEPT AN INLET BARRIER FILTER FOR THE FIRE-RESCUE DEPARTMENT'S NEW HELICOPTER.

WHEREAS, Aerometals Inc. (Aerometals) approached the City for participation in a "Lead the Fleet" program; and

WHEREAS, under this program Aerometals will provide the City with an Inlet Barrier Filter (IBF); and

WHEREAS, in exchange for the IBF, the City would provide Aerometals with data evaluation, press releases, photos and feedback for use in Aerometals' marketing efforts; and


WHEREAS, Aerometals will provide and install at no cost to the Fire-Rescue Department the IBF, valued at \$220,000, on Fire-Rescue's new Sikorsky S70i helicopter; and

WHEREAS, since Fire-Rescue Department fire helicopters operate in smoke and dusty conditions, the IBF will provide clean filtered air to the engines thereby eliminating sand erosion and preventing contaminants from causing damage that results in maintenance costs and helicopter unavailability; and

WHEREAS, upon completion of the performance evaluation period outlined in the agreement, title of the IBF will transfer to the City; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to enter into a marketing agreement with Aerometals Inc. for the Inlet Barrier Filter from Aerometals, Inc. to be installed on the Fire-Rescue Department's new Sikorsky S70i helicopter.
