A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN  
REX PANTON AND THE CITY OF SAN DIEGO

WHEREAS, on January 11, 2017, REX PANTON filed a claim against the City of San Diego [City] alleging property damage arising from damage to his property at 5395 Middleton Road; and

WHEREAS, in Closed Session on April 10, 2018, the City Council, by the following votes: Yeas, District(s) 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and absent, 1, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego that the Council:

1. A resolution authorizing the Mayor or his designee to pay the sum of \$61,147.87 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the property damage claim filed by Rex Panton.

2. Authorizes the Chief Financial Officer to appropriate and expend \$61,147.87 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizes the Comptroller to issue a check in the amount of \$61,147.87, made payable to Rex Pantan.
