DATE OF FINAL PASSAGE JUN 15 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING AMENDMENTS TO THE PUBLIC FACILITIES, SERVICES AND SAFETY ELEMENT OF THE GENERAL PLAN.

WHEREAS, on March 10, 2008, the City Council adopted an update to the City's General Plan (General Plan), which sets forth a long-range vision and comprehensive policy framework for how the City should plan for projected growth and development, provide public services, and maintain the qualities that define the City of San Diego; and

WHEREAS, a City's general plan must include a safety element setting forth goals, policies, and objectives to protect the community from any unreasonable risks associated with various public safety hazards, including wildland and urban fires, in accordance with Government Code section 65302(g); and

WHEREAS, on September 13, 2012, the Governor signed Senate Bill 1241, which amended Government Code section 65302(g)(3) to require review and update of a City's safety element to address the risk of fire for land classified as either state responsibility areas, as defined in Public Resources Code section 4102, or very high fire hazard severity zones, as defined in Government Code section 51177; and

WHEREAS, San Diego Municipal Code section 55.9401 codifies several very high fire hazard severity zones located throughout the City of San Diego; and

WHEREAS, the proposed amendments to Sections D and P of the General Plan's Public Facilities, Services and Safety Element (General Plan Amendments) include City goals, policies, and objectives for protecting the community from the unreasonable risk of wildfires, identifying

the City's wildfire hazard severity zones, and outlining climate resiliency and adaptation plans;
and

WHEREAS, on March 22, 2018, the Planning Commission of the City of San Diego voted to recommend approval of the General Plan Amendments; and

WHEREAS, the Planning Commission of the City of San Diego found the proposed amendment consistent with the General Plan and recommended that the City Council adopt the proposed amendments to the General Plan; and


WHEREAS, on April 18, 2018, the Smart Growth and Land Use Committee of the City Council voted to recommend approval of the General Plan Amendments; and

WHEREAS, on June 12, 2018, the City Council held a public hearing for the purpose of considering an amendment to the General Plan; and

WHEREAS, the City Council has considered all written documents contained in the file for this project on record in the City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Council adopts the amendment to the General Plan, a copy of which is on file in the office of the City Clerk as Document No. RR 311806.



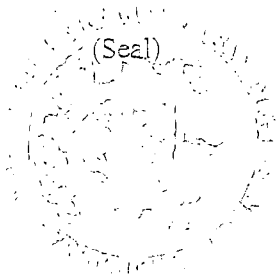
