WHEREAS, these rules and regulations are to be called Standard Operating Procedures, and may be amended only with the approval of the Mayor and the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Standard Operating Procedures for the Community Review Board on Police Practices are hereby adopted.

BE IT FURTHER RESOLVED, that a copy of the Standard Operating Procedures as adopted be placed on file in the Office of the City Clerk as Document No. RR-311813
