SAN DIEGO AMENDING COUNCIL POLICY 100-20,  
ENTITLED "RESERVE POLICY" FOR DEVELOPMENT  
SERVICES ENTERPRISE RESERVE POLICY.

WHEREAS, the Development Services Enterprise Fund Reserve Policy, part of Council  
Policy 100-20 "Reserve Policy," currently sets a maximum operating reserve target level of 15%  
to be reached by Fiscal Year 2022; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:


