A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING INITIATION OF A MODIFICATION FOR THE SAN DIEGO RIVER VALLEY GROUNDWATER BASIN WITH THE CALIFORNIA DEPARTMENT OF WATER RESOURCES.

WHEREAS, the Sustainable Groundwater Management Act (SGMA) requires water agencies to form Groundwater Sustainability Agencies (GSA), which in turn adopt Groundwater Sustainability Plans (GSP) for long-term sustainable management and protection of groundwater resources; and

WHEREAS, to implement SGMA in the San Diego River Valley Groundwater Basin, the City of San Diego (City) needs to correct the groundwater basin boundary by initiating a basin boundary modification application with the California Department of Water Resources (DWR); and

WHEREAS, to initiate the basin boundary modification application, a governing body resolution is required to align the existing basin boundary using geologic science to include all the appropriate alluvial locations inside the basin boundary to facilitate management of the state's water resources; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to initiate a basin boundary modification for the San Diego River Valley Groundwater Basin with the California Department of Water Resources.
