A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO EXECUTE AN AGREEMENT WITH ENFORCEMENT SUPPORT SERVICE, INC., IN AN AMOUNT OF \$218,400 PER FISCAL YEAR FOR FISCAL YEAR 2019 AND FOUR OPTIONAL ONE YEAR EXTENSIONS FOR FISCAL YEARS 2020 THROUGH 2023, TO PROVIDE TECHNICAL CONSULTANT SERVICES TO THE SAN DIEGO POLICE DEPARTMENT.

WHEREAS, the San Diego Police Department (Police Department) utilizes a complex system of computers, networks, interfaces, and applications, including a new Computer Aided Dispatch (CAD) system, used to respond to emergency and non-emergency calls for service and for dispatching of police officers; and

WHEREAS, Enforcement Support Service, Inc. (ESS) has highly specialized technical and institutional knowledge of critical Police Department public safety computer systems, including the Computer Aided Dispatch (CAD) and Mobile for Public Safety (MPS) systems, and related interfaces, networks, and applications; and

WHEREAS, ESS has historically provided essential technical support for Police

Department computer systems; and

WHEREAS, the Mayor previously entered into an agreement with ESS for technical support of its proprietary message switching system used by the Police Department, and support during the Police Department's anticipated transition to a new CAD system (Council Resolution R-308998 (June 10, 2014)); and

WHEREAS, the previous agreement with ESS expires on June 30, 2018; and

WHEREAS, the Police Department implemented a new CAD system in October 2017; and

WHEREAS, during the transition to the new CAD system, ESS provided technical support regarding interfaces and networking, enabling a successful implementation of the new CAD system; and

WHEREAS, technical support by ESS continues to be instrumental in maintaining continuous availability of the new CAD system and related subsystems, and ensuring uninterrupted public safety responses; and

WHEREAS, historical data contained within the legacy CAD system must be retained for at least four years, as mandated by the City of San Diego, Police Record Series number 90 adopted by Council Resolution R-309234 on September 23, 2014; and

WHEREAS, ESS will provide support for the legacy CAD system, ensuring this data is properly retained; and

WHEREAS, based on the unique knowledge of and experience with Police Department systems provided by ESS, a sole source certification was authorized by the Purchasing and Contracting Department; and

WHEREAS, the Police Department seeks authorization for the Mayor to enter into a new agreement with ESS for continued technical support for mission-critical computer systems and required retention of historical data; and

WHEREAS, the annual cost of this agreement will be \$218,400, structured as a one (1) year agreement for Fiscal Year 2019, with four (4) optional one (1) year extensions, not to exceed five years, through Fiscal Year 2023; and

WHEREAS, the Fiscal Year 2019 Police Department General Fund operating budget

includes \$218,400 for this agreement with ESS; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his

designee, is authorized to approve and execute a one-year agreement with four optional one-year

extensions with Enforcement Support Service, Inc. for technical consultant services, in an

amount of \$218,400 per fiscal year.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount of \$218,400 per fiscal year for consultant services, contingent upon the adoption of

the Annual Appropriations Ordinance for the applicable fiscal year, and contingent upon the

Chief Financial Officer first furnishing a certification certifying that funds necessary for this

expenditure are, or will be, on deposit with the City Treasurer.
