A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE FIRST AMENDMENT TO
THE CONSULTANT AGREEMENT BETWEEN THE CITY OF
SAN DIEGO AND O'DAY CONSULTANTS.

WHEREAS, on April 21, 2016, the City of San Diego (City) entered into an agreement with O'Day Consultants (Consultant) to provide additional as-needed land surveying services, on file in the Public Works Department as Contract No. H156449 (Agreement); and

WHEREAS, the City desires, and Consultant agrees to execute an amendment to the Agreement for the Consultant to provide additional as-needed land surveying consultant services with compensation in an additional amount not to exceed \$1,500,000 for a total amount not to exceed \$3,500,000; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to execute the First Amendment to the Agreement with Consultant for as-needed land surveying consultant services in an additional amount not to exceed \$1,500,000 for a total amount not to exceed \$3,500,000, under the terms and conditions set forth in the First Amendment to Agreement on file in the Office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the Chief Financial Officer as delegated to Financial Management is authorized to appropriate and the City Comptroller is authorized to expend an additional amount not to exceed \$1,500,000 for a total amount not to exceed \$3,500,000 over five (5) years for the purpose of funding the consultant agreement with Consultant, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and

contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
