A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE AUTHORIZATION OF THE EXECUTION OF THE CITY OF SAN DIEGO FLAT RATE LEASE WITH COAST AIR CENTER LLC FOR THE LEASE OF APPROXIMATELY 9.4 ACRES AT MONTGOMERY-GIBBS EXECUTIVE AIRPORT AND TO WAIVE COUNCIL POLICY 700-10 REGARDING THE MAXIMUM LOAN PROCEEDS NOT TO EXCEED SEVENTY-FIVE PERCENT LOAN TO VALUE OF THE LEASEHOLD IMPROVEMENTS, IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) PURSUANT TO CEQA GUIDELINES SECTIONS 15301, 15302, 15303, AND 15304.

WHEREAS, the California Environmental Quality Act (CEQA) (California Public Resources Code section 21000, *et seq.*), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, section 15000, *et seq.*) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of Projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the City of San Diego (City) desires to authorize the execution of the City of San Diego Flat Rate Lease with Coast Air Center LLC for the lease of approximately 9.4 acres at Montgomery-Gibbs Executive Airport, on file in the Office of the City Clerk as Document No. RR-311864, and waive Council Policy 700-10 regarding the maximum loan proceeds not to exceed seventy-five percent loan to value of the leasehold improvements (Project); and

WHEREAS, the Planning Department has established that the Project is categorically

exempt from CEQA pursuant to CEQA Guidelines section 15301 (Existing Facilities), 15302

(Replacement or Reconstruction of Existing Structures and Facilities), 15303 (New Construction

or Conversion of Small Structures) and 15304 (Minor Alterations to Land), and that no exception

to the exemption, as set forth in CEQA Guidelines section 15300.2, applies to the Project; and

WHEREAS, the Council of the City of San Diego (Council) has considered the potential

environmental effects of the Project; and

WHEREAS, the Council held a duly noticed public meeting and considered the written

record for the Project as well as public comment, NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego, using its independent

judgment, has considered the written record and public comment for the authorization of the

Project, and determines that the Project is categorically exempt from CEQA pursuant to CEQA

Guidelines sections 15301 (Existing Facilities), 15302 (Replacement or Reconstruction of

Existing Structures and Facilities), 15303 (New Construction or Conversion of Small Structures)

and 15304 (Minor Alterations to Land), and that an exception to the exemption as set forth in

CEQA Guidelines section 15300.2 does not apply.
