DATE OF FINAL PASSAGE JUL 23 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE ESTABLISHMENT OF A FEE FOR SHORT TERM RESIDENTIAL OCCUPANCY LICENSES FOR INCLUSION IN THE RATEBOOK OF CITY FEES AND CHARGES MAINTAINED IN THE OFFICE OF THE CITY CLERK.

WHEREAS, Ordinance No. O- 20978, which is considered along with this resolution, establishes a license process and effective enforcement program for short term residential occupancy regulations; and

WHEREAS, it is the policy of the City of San Diego to establish fees to recover the costs of providing services in accordance with San Diego Administrative Regulation 95.25 and Council Policy 100-05 "User Fee Policy"; and

WHEREAS, the Development Services Department, Office of the City Treasurer, City Attorney's Office, and the Police Department evaluated the costs associated with providing the services for which fees are charged; and

WHEREAS, the proposed fees reflect the estimated reasonable cost of providing the service for which the fees are charged as set forth in the staff report, dated July 9, 2018, "An Amendment to the City's Municipal Code and Local Coastal Program to Include Regulations for Short Term Residential Occupancy and Approve the Establishment of a Fee to Provide Full Cost Recovery for Permitting and Enforcement Costs"; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that upon the effective date of Ordinance No. O- 20978, a \$949 fee for Short Term Residential Occupancy Licenses, to be paid before the issuance of a Short Term Residential Occupancy License, is

approved for the purpose of recovering costs incurred by the City of San Diego in issuing each Short Term Residential Occupancy License and the anticipated enforcement costs.

BE IT FURTHER RESOLVED, that the City Clerk is directed to amend the Ratebook of City Fees and Charges maintained in the Office of the City Clerk to include the fee described above.

BE IT FURTHER RESOLVED, that the requirement for proposed fees to be reviewed by the Budget and Finance Committee (now the Budget and Government Efficiency Committee) as set forth in Council Policy 100-05, User Fee Policy, is waived.
