A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE ESTABLISHMENT OF AN AFFORDABLE HOUSING IMPACT FEE RELATED TO SHORT TERM RESIDENTIAL OCCUPANCY.

WHEREAS, short term residential occupancy (STRO) and the associated visitor spending creates jobs, some of which are low paying, and therefore creates a need for affordable housing, the City desires to require the payment of a nightly Affordable Housing Impact Fee for STRO to assist with the creation of affordable housing; and

WHEREAS, the Housing Element of the City of San Diego's General Plan contains specific policies and goals for increasing housing opportunities for households at various income levels, such as the use of fees to promote affordable housing, the need to provide workforce housing, and the availability of the Affordable Housing Fund (of which the Affordable Housing Impact Fee on STRO's will form a part) to pursue the City's housing goals; and

WHEREAS, Ordinance No. O- 20978, which is considered along with this resolution, establishes regulations and an effective enforcement program for STRO; and

WHEREAS, according to a June 2018 Short Term Rental Nexus Study from Keyser Marston Associates, a legal nexus exists between STRO and visitor spending and the need for affordable units for the lower paying jobs (such as house cleaners, maintenance persons, gardeners, hosts or hostesses, cashiers, dishwashers) generated by STRO and associated visitor spending; and

WHEREAS, the June 2018 Short Term Rental Nexus Study demonstrates that there is a reasonable relationship between the proposed fee and the impacts caused by the STRO subject to the fee; and

WHEREAS, the June 2018 Short Term Rental Nexus Study demonstrates, by facts and analysis, that the nexus methodology revolves around the concept that spending generates jobs: portion of these jobs pay low wages, and therefore create the need for affordable housing for these low-income wage earners; and

WHEREAS, the City Council finds that the fee established by this ordinance are not being established to ameliorate the existing shortage of affordable housing but only the housing needs of the people in jobs created by new STRO; and

WHEREAS, the fees for STRO are supported by the June 2018 Short Term Rental Nexus Study and are being recommended at a rate of \$2.73 per night for home share, and \$3.96 per nights for whole home; and

WHEREAS, the City Council finds that the fee, on per night basis, is being set in a way so that the fee is roughly proportional to, but less than, the public burden caused by the need for affordable housing needs generated by STRO and related visitor spending and is necessary to allow for the creation and provision of housing for the low, very low, and extremely low-income households that work within the STRO units and related visitor spending industries; and

WHEREAS, the City Council finds that fee is, in aggregate, only a small portion of the total revenue needed to acquire, create, or otherwise provide housing for these low, very low, and extremely low households (which new housing does not currently exist), because these fees will need to be leveraged with the Housing Impact Fees and other revenue sources; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the aforementioned statements, along with the record from the public hearings of July 16, 2018, considered either individually or collectively, form a basis upon which the City Council adopts the Affordable Housing Impact Fee of \$2.73 per night per home share STRO and \$3.96 per night per whole home STRO.

BE IT FURTHER RESOLVED, that the requirement for proposed fees to be reviewed by the Budget and Finance Committee (now the Budget and Government Efficiency Committee) as set forth in Council Policy 100-05, User Fee Policy, is waived.
