A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ADOPTION OF THE WATER SUPPLY ASSESSMENT FOR THE UNIVERSITY OF CALIFORNIA, SAN DIEGO LONG RANGE DEVELOPMENT PLAN UPDATE PROJECT.

WHEREAS, a Water Supply Assessment (WSA) evaluates water supplies that are, or will be, available during normal, single-dry year, and multiple-dry water years during a 20-year projection to meet projected demands of a project in addition to existing and planned future water demands of the Public Utilities Department (PUD); and

WHEREAS, the WSA was completed by PUD in compliance with the requirements under California Senate Bill 610 and in consultation with the City of San Diego Development Services Department (DSD), San Diego County Water Authority (SDCWA), and Metropolitan Water District of Southern California (MWD); and

WHEREAS, the proposed project is located on each of the three land parcels of the campus and housing area totaling an area of 1,158 acres (Project), and the University of California (UC) requires each campus in the UC system to maintain a Long-Range Development Plan (LRDP) as a guide for capital project development and review; and

WHEREAS, the WSA demonstrates there will be sufficient water supplies available during normal, single-dry year, and multiple-dry water years over 20 years to meet the projected level of water demand for this Project in consideration of regional water resource planning documents of the City, SDCWA, and MWD; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Water Supply Assessment for the University of California, San Diego Long-Range Development Plan Update Project is adopted to fulfill the requirements of California State Water Code Section 10910.
