A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE ALLOCATION OF FUNDING FOR THE MURPHY CANYON ROAD TRANSMISSION LINE UNDERGROUNDING PROJECT AND THE UNDERGROUDING OF NEARBY DISTRIBUTION LINES.

WHEREAS, Council Policy 600-08, which establishes overarching policy on the use of Utilities Undergrounding Program funds, allows funds to be used to relocate overhead power transmission lines underground where feasible; and

WHEREAS, approximately 3.7 miles of overhead 69-kilovolt (kV) power transmission lines located along Complex Street, Clairemont Mesa Boulevard, and Murphy Canyon Road are due for replacement of conductor wires; and

WHEREAS, SDG&E has agreed to relocate these lines underground at an estimated cost of \$23 million in coordination with their conductor replacement project, contingent upon the City of San Diego (City) partially funding the work using the Underground Surcharge Fund; and

WHEREAS, this action is to approve the proposed transmission lines undergrounding at an estimated City cost share of \$9.8 million, approve the undergrounding of distribution lines at an additional estimated cost of \$10.6 million bringing the total estimated cost to the City to \$20.4 million, NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the proposed transmission lines undergrounding project utilizing the Surcharge Funds allocated at the discretion of the Mayor, in accordance with section B.3.b.1(a).1 of Council Policy 600-08, is approved.

BE IT FURTHER RESOLVED, the proposed distribution lines undergrounding project as a part of the annual allocations for Council District 6, in accordance with Section B.3.b.1 (b) of Council Policy 600-08, is approved.
