DATE OF FINAL PASSAGE JUL 30 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE REVISED PEDICAB PERMIT
FEES AND DIRECTING THE CITY CLERK TO AMEND THE
CITY RATEBOOK.

WHEREAS, the City of San Diego (City) regulates the pedicab industry through the San Diego Police Department (Police Department); and

WHEREAS, pedicabs have been a police regulated business since 2015; and

WHEREAS, the Police Department conducted a full evaluation of the costs of regulating pedicab owners and operators; and

WHEREAS, the Police Department's costs are reflected in the fees charged to pedicab owners and operators for pedicab decals and pedicab operating permits; and

WHEREAS, the proposed pedicab fees for Fiscal Year 2019 include the costs of issuing police permits, and investigation, inspection, administration, supervision, and enforcement; and

WHEREAS, the pedicab fees comply with Proposition 26 as a reasonable regulatory cost exception, and do not exceed reasonable costs of regulating pedicab owners and operators; and

WHEREAS, Administrative Regulation 95.25 encourages transferring specific fees listed in the San Diego Municipal Code and Council Resolutions to the standardized Ratebook maintained by the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that an increase in the fee to process a new application for either a traditional or specialized pedicab from \$56.00 to \$59.00 is hereby approved.

BE IT FURTHER RESOLVED, that an increase in the fee to process a renewal application for either a traditional or specialized pedicab from \$52.00 to \$54.00 is hereby approved.

BE IT FURTHER RESOLVED, that an increase in the fee for a traditional pedicab decal from \$122.00 to \$160.00 is hereby approved.

BE IT FURTHER RESOLVED, that an increase in the fee for a traditional pedicab operator permit from \$212.00 to \$409.00 is hereby approved.

BE IT FURTHER RESOLVED, that a new fee of \$152.00 for a specialized pedicab decal is hereby approved.


BE IT FURTHER RESOLVED, that a new fee of \$128.00 for a specialized pedicab operator permit is hereby approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to amend the City Ratebook to include the pedicab fees authorized by this Resolution.

BE IT FURTHER RESOLVED, that the revised pedicab fees will be effective October 1, 2018.
