WHEREAS, the Business Incentive Workplan sets forth the additional criteria the City will use to evaluate a business's application for an incentive award under Council Policy 900-12; and

WHEREAS, the Business Incentive Workplan will be amended, from time to time as needed, to adapt to changes in the local economy, to address the region's changing needs, to revise the business activities prioritized by the City, or to address any other changes needed to align the additional criteria identified in the Business Incentive Workplan with the City's current goals, priorities, needs, or opportunities; NOW, THEREFORE,
