

RESOLUTION NUMBER R- 311917

DATE OF FINAL PASSAGE JUL 30 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DIRECTING PUBLISHING REQUIREMENTS IN COMPLIANCE WITH SAN DIEGO MUNICIPAL CODE SECTION 27.0516 FOR A MEASURE TITLED "SAN DIEGO RIVER PARK AND SOCCER CITY INITIATIVE," TO BE SUBMITTED TO THE QUALIFIED VOTERS OF THE CITY OF SAN DIEGO AT THE MUNICIPAL SPECIAL ELECTION TO BE HELD ON NOVEMBER 6, 2018.

WHEREAS, section 27.0516 of the San Diego Municipal Code (Municipal Code) requires the full text of each ballot measure submitted to voters at a Municipal Special Election to be published in the voter pamphlet sent to voters; and

WHEREAS, Municipal Code section 27.0516(b) provides for one exception, if the text of a ballot measure submitted to the City Clerk is not a Charter amendment and exceeds 50 pages, in which case "the voter pamphlet shall contain the first 20 pages of the text of the measure as submitted to the Clerk"; and

WHEREAS, if only the first 20 pages of the text are printed, Municipal Code section 27.0516(b) further requires the City Clerk to cause or direct other actions in which the full text of the measure would be provided to voters by posting it on the City website, providing it to libraries, mailing it to any voter (at no cost to the voter) upon request, and explaining in the voter pamphlet where the full text is available; and

WHEREAS, voters will also receive the ballot title and summary, impartial analysis, fiscal impact analysis, and arguments, if any, in the voter pamphlet; and

WHEREAS, Municipal Code section 27.0516(b) further provides that the Council has the discretion to adopt a resolution, effective no later than the 94th day prior to the date of the election, requiring publication of the full text of a measure that exceeds 50 pages, if desired; and

WHEREAS, the text of a citizens' initiative measure titled "San Diego River Park and Soccer City Initiative" is not a Charter amendment, exceeds 50 pages, and will be submitted to the qualified voters of the City at the Municipal Special Election to be held November 6, 2018; and

WHEREAS, the Council now confirms its direction to the City Clerk, in compliance with Municipal Code section 27.0516(b), that the first 20 pages of the text of the measure as submitted to the Clerk will be published in the voter pamphlet, and to direct that the Clerk cause or direct the actions specified in related provisions in Municipal Code sections 27.0516(2)(a) through 27.0516(2)(e); and

WHEREAS, pursuant to Charter section 295(d), this resolution relating to matters to submit to City voters at a Municipal Special Election is not subject to veto by the Mayor, and thus the date of its passage by the Council shall be deemed the date of final passage; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The voter pamphlet for the November 6, 2018 Municipal Special Election shall include the first 20 pages of the text of the citizens' initiative measure titled, "San Diego River Park and Soccer City Initiative," as provided in San Diego Municipal Code section 27.0516(b) for measures that are not Charter amendments and exceed 50 pages when submitted to the City Clerk.

2. The City Clerk is directed to cause or direct the related actions specified in Municipal Code sections 27.0516(2)(a) through 27.0516(2)(e), including provisions that require posting the full text of the measure on the City website, providing it to libraries, mailing it to any

voter (at no cost to the voter) upon request, and explaining in the voter pamphlet where the full text is available.

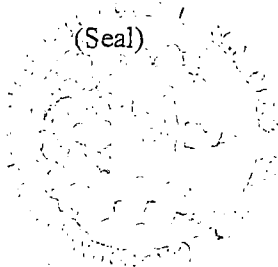
