A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO AN AGREEMENT WITH HAWTHORNE MACHINERY COMPANY FOR THE LEASE AND FULL MAINTENANCE OF HEAVY DUTY LANDFILL EQUIPMENT FOR THE MIRAMAR LANDFILL.

WHEREAS, on March 25, 2014, by Resolution No. R-308836, the City Council authorized an agreement with Hawthorne Machinery Company for the lease and full maintenance of heavy duty landfill equipment for the Miramar Landfill, in an amount not to exceed \$3,900,000 (Agreement); and

WHEREAS, the City desires to increase the total compensation under the Agreement by an amount not to exceed \$500,000 to cover equipment repair costs, as needed, until the termination of the Agreement; and

WHEREAS, funding will come from the Refuse Disposal Fund No. 700039, with \$200,000 allocated in Fiscal Year 2018, and \$300,000 in Fiscal Year 2019; and

WHEREAS, upon City's written consent, Contractor may defer any non-critical repairs as further described in the First Amendment to Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute the First Amendment to Agreement with Hawthorne Machinery Company for the lease of heavy duty landfill equipment with full maintenance in an amount not to exceed \$500,000, under the terms and conditions set forth in the First Amendment to Agreement on file in the Office of the City Clerk as Document No. RR-311927.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$200,000 from the Refuse Disposal Fund No. 700039, for Fiscal Year 2018, solely and exclusively to provide funds for the First Amendment to the Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates demonstrating that the funds are, or will be, on deposit with the City Treasury.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$300,000 from Refuse Disposal Fund No. 700039, for the remaining term of the Agreement beginning in Fiscal Year 2019, solely and exclusively to provide funds for the First Amendment to the Agreement, contingent upon Council approval of the annual Appropriations Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer first furnishing one or more certificates demonstrating that funds are, or will be, on deposit with the City Treasury.
