A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING COUNCIL POLICY 000-12
ENTITLED "RACIAL DISCRIMINATION."

WHEREAS, Council Policy 000-12 entitled "Racial Discrimination" was adopted as a Council Policy of the City of San Diego (City) on February 20, 1968; and

WHEREAS, Council Policy No. 000-12 has not been amended since it was first adopted; and

WHEREAS, the Council wishes to reaffirm that it does not tolerate racial discrimination in any form; and

WHEREAS, the Council wishes to protect and safeguard the right and opportunity of all persons to live free of racial discrimination; and

WHEREAS, the Council recognizes that the unequal treatment of people based on race creates strife and unrest, and adversely affects the interests of employees, the City, and the public in general; and

WHEREAS, it is the purpose of this policy to affirm that racial or identity profiling is a form of discrimination; and

WHEREAS, the California Commission on Peace Officer Standards and Training (POST), as codified in Chapter 1 of the California Penal Code (sections 13500 - 13553), develops guidelines and training for all peace officers in California; and

WHEREAS, the Commission on POST defines racial or identity profiling in section 13519.4(e) of the California Penal Code, in relevant part, as "the consideration of, or reliance on, to any degree, actual or perceived race, color, [or] ethnicity . . . in deciding which

persons to subject to a stop or in deciding upon the scope or substance of law enforcement activities following a stop, except that an officer may consider or rely on characteristics listed in a specific suspect description;” and

WHEREAS, it is the purpose of this policy to promote racial equality; and

WHEREAS, the Council wishes to permit full access to economic, political, educational, and social opportunities and to eliminate the effects of racial inequality and prejudice when it is found; and


WHEREAS, it is the purpose of this policy to assure that there shall not be any decision, policy, program, or act of administration at any level of City government that is inconsistent with this policy;

WHEREAS, the Council wishes to place this policy in the Council Policy Manual; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that Council Policy No. 000-12, entitled “Racial Discrimination,” is amended as set forth in the Council Policy filed in the Office of the City Clerk as Document No. RR 311929.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to update the Council Policy Manual to include the revised Council Policy No. 000-12.
