City of San Diego*, San Diego Superior Court Case No. 37-2017-00033460-CU-PO-CTL.

2. Authorizes the Chief Financial Officer to expend \$70,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
