A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF THE FIRST AMENDMENT TO THE STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION AIRSPACE GROUND LEASE WITH THE STATE OF CALIFORNIA, FOR THE REAL PROPERTY LOCATED AT 299 17TH STREET, SAN DIEGO, CALIFORNIA, KNOWN AS THE NEIL GOOD DAY CENTER.

WHEREAS, the State of California, acting by and through the Department of Transportation (State), owns the real property located at 299 17th Street, San Diego, California (Property), which is improved with a homeless day center, known as the Neil Good Day Center; and

WHEREAS, the Property is leased to the City of San Diego (City) pursuant to the State of California Department of Transportation Airspace Ground Lease (Lease), on file in the Office of the City Clerk as Document No. RR-275416, and is used and operated by Father Joe's Villages for emergency shelter and feeding program purposes as set forth in California Streets and Highways Code section 104.18 during daylight hours; and

WHEREAS, the Property was recently updated with necessary repairs and maintenance items utilizing United States Department of Housing and Urban Development (HUD) funds, which require the City have a lease in effect for a period of five years; and

WHEREAS, the Lease is scheduled to expire on October 31, 2020, prior to the 5-year requirement for the HUD funds; and


WHEREAS, the City has requested of the State to extend the term of the Lease by two years, to expire on October 31, 2022, and the State has agreed to this extension recognizing the growing need for emergency shelter services and food programs for the homeless; and

WHEREAS, City will pay the monthly rental rate of \$1.00 and the annual administrative fee in the amount of \$500.00, as set forth in California Streets and Highways Code section 104.18, for the two-year extension to the term; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized and directed to execute the First Amendment to the State of California, Department of Transportation Airspace Ground Lease, with the State of California, acting by and through the Department of Transportation, to extend the term of the Lease by 2 years to a total term of thirty-two (32) years for the real property located at 299 17th Street, San Diego, California, the terms of which are more fully set forth therein, and which is on file in the Office of the City Clerk as Document No. RR- 311954.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,024.00, for 2 years of rent and the annual administrative fee, from the Community Development Grant Fund No. 600000, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for the expenditure are, or will be, on deposit with the City Treasurer.
