A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE AWARD AND
EXECUTION OF A STREET MAINTENANCE CONTRACT
FOR SLURRY SEAL GROUP 1901 AND RELATED FUNDING
ACTIONS.

WHEREAS, this action will award and execute a street maintenance contract for Slurry Seal Group 1901 to provide for the repair and slurry sealing of approximately 30 miles of asphalt streets located in Council Districts 1, 2, 5 and 6; and

WHEREAS, in Fiscal Year 2019, the Resurfacing Program plans to slurry seal 290 miles of streets in support of the Mayor's commitment to repair 1,000 miles of roads; and

WHEREAS, the contract was advertised from June 26, 2018 through July 26, 2018 and, due to rising material costs, the lowest bid of \$3,231,436.61 exceeded the engineer's initial estimate, thereby requiring Council approval to execute this contract; and

WHEREAS, the contract for Slurry Seal Group 1901 involves furnishing all labor, materials, equipment, and construction, including crack sealing, pavement repair, slurry sealing, replacing traffic striping/markings, traffic control plans, and storm drain inlet protection on various public streets located throughout the City; and

WHEREAS, streets selected for Slurry Seal Group 1901 are located in Council Districts 1, 2, 5, and 6, however, to avoid any construction conflicts, the final lists of streets may be modified using a Pavement Management System and streets are selected for slurry sealing based on the following established criteria: Overall Condition Index (OCI), Maintenance History, Functional Classification, Proximity to Emergency Facility/School/Tourist Attraction, and Mayor/Council Input; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to award and execute a construction contract with the lowest responsible and reliable bidder, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.

2. That the Chief Financial Officer is authorized to expend funds not to exceed \$1,557,493.69 from Fund 200118, Gas Tax Fund and \$1,842,506 from Fund 200731, Road Maintenance and Rehabilitation Fund for the purpose of funding Slurry Seal Group 1901 construction contract, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
