A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING SETTLEMENT OF FRANCES EZELLA MORALES

WHEREAS, on April 18, 2016, Plaintiff Frances Ezella Morales filed suit against the City of San Diego alleging personal injuries arising from a trip and fall accident over an uplifted portion of sidewalk on south Beech Street in downtown San Diego; Plaintiff brought suit in the San Diego Superior Court. The suit is entitled *Frances Ezella Morales v. City of San Diego*, Case No. 37-2016-00012579-CU-PO-CTL; and

WHEREAS, in closed session on July 31, 2018, the City Council, by the following votes: Yeas, Districts 1, 3, 4, 5, 7, 9; Nays, Districts 2, 8, Absent, District 6, approved the City's settlement of Frances Ezella Morales' claim for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in a settlement release; NOW, THEREFORE; and

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

- 1. A resolution authorizing the Mayor or his designee to pay the sum of \$230,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury complaint filed by Frances Morales, entitled *Frances Ezella Morales v. City of San Diego*, Case No. 37-2016-00012579-CU-PO-CTL.
- 2. Authorizes the Chief Financial Officer to expend \$230,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizes the Comptroller to issue a check in the amount of \$230,000.00, made payable to B&D Law Group, APLC Client Trust Account for Frances Ezella Morales.
