A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT TO A CONSULTING CONTRACT WITH CONDUENT HR SERVICES FOR BENEFITS CONSULTING, BROKERAGE, AND ACTUARIAL SERVICES, AND ADDITIONAL FUNDING FOR THE CONTRACT.

WHEREAS, on December 5, 2017, the San Diego City Council (City Council) approved a contract with Conduent HR Consulting to provide benefits consulting, brokerage, and actuarial services (San Diego Resolution R-311435); and

WHEREAS, the contract is for a period not to exceed five years and in an overall amount of \$1,577,000; and

WHEREAS, the City has an immediate need for Conduent HR Consulting to provide additional benefits consulting and actuarial services to evaluate and analyze the potential impacts of any court-ordered remedies related to the ongoing Proposition B litigation; and

WHEREAS, it is estimated supplemental funds not to exceed \$100,000 will be needed for the additional benefits consulting and actuarial services; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to approve and execute the First Amendment to the Benefits Consulting, Brokerage, and Actuarial Services Contract for additional benefits consulting and actuarial services in an amount not to exceed \$100,000, resulting in a total not to exceed amount for the five-year period of \$1,677,000.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$100,000 for Fiscal Year 2019 for benefits consulting and actuarial services contingent upon the Chief Financial Officer furnishing a certificate verifying that the funds necessary for the expenditure are, or will be, on deposit with the City Treasurer.
