A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING STREET NAME CHANGE FOR A ONE-BLOCK PORTION OF PARK BOULEVARD BETWEEN IMPERIAL AVENUE AND TONY GWYNN DRIVE TO TREVOR HOFFMAN WAY.

WHEREAS, this street name change proposal is located on a one-block portion of Park Boulevard, located between Imperial Avenue and Tony Gwynn Drive, adjacent to Petco Park; and

WHEREAS, Park Boulevard is a four-lane local street approximately 0.10 mile in length, within the Ballpark mixed-use zone of the East Village neighborhood of the Downtown Community Plan area; and

WHEREAS, on August 15, 2018, the Downtown Community Planning Council voted 13-1-2 to recommend approval of the street name change; and

WHEREAS, the proposal plans to change the name of a one-block portion of Park Boulevard between Imperial Avenue and Tony Gwynn Drive, from Park Boulevard to Trevor Hoffman Way, in honor of Trevor Hoffman an American former baseball relief pitcher who played 18 years in Major League Baseball (MLB) from 1993 to 2010 and was inducted into the Baseball Hall of Fame in 2018; and

WHEREAS, this proposed street name change complies with all the criteria established by San Diego Municipal Code (SDMC) Section 125.1120; and

WHEREAS, SDMC Section 125.1120 is the established procedure governing proposed street name changes. A petition was circulated and one signature of affected property owners was obtained; and

WHEREAS, this does not represent 100 percent support of all affected property

owners, therefore a decision by the City Council is required per SDMC Section

125.1110(b)(2); and

WHEREAS, in accordance with SDMC Section 125.1120(c), City staff determined the

project does not adversely affect the multi-agency computer aided dispatch service for police,

fire, and paramedic vehicles, or the policies and procedures of the United States Postal Service as

"Trevor Hoffman Way" has not been previously assigned as a street name in the City of San

Diego; and

WHEREAS, the request has been processed in accordance with Process Five, except

that a Planning Commission recommendation hearing is not required prior to a City Council

decision; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

That the name of one-block portion of Park Boulevard, located between 1.

Imperial Avenue and Tony Gwynn Drive adjacent to Petco Park, more particularly shown

on Drawing No. 40928-1-B, attached hereto as Exhibit "A," is changed to Trevor Hoffman

Way.

That the street name change does not adversely affect the multi-agency computer 2.

aided dispatch service for police, fire, and paramedic vehicles, or the policies and procedures of

the United States Postal Service as "Trevor Hoffman Way" has not been previously assigned as a

street name in the City of San Diego.


