DATE OF FINAL PASSAGE SEP 25 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING THE APPOINTMENT OF
KYLE ELSER AS INTERIM CITY AUDITOR.

WHEREAS, San Diego Charter section 39.2 provides that the City Auditor shall be appointed by the Mayor, in consultation with the Audit Committee, and confirmed by the City Council; and

WHEREAS, on April 14, 2009, the City Council confirmed the appointment of City Auditor Eduardo Luna, with a ten-year term expiring in April 2019; and

WHEREAS, Mr. Luna has announced his resignation as City Auditor, effective September 28, 2018; and

WHEREAS, the City is conducting a recruitment to fill the position of City Auditor for a full-term consistent with Charter sections 39.1 and 39.2; and

WHEREAS, on September 12, 2018, the Mayor reported to the Audit Committee, recommending the Audit Committee concur in the appointment of Kyle Elser, Assistant City Auditor, to be appointed Interim City Auditor and fulfill the role of the City Auditor under Charter section 39.2 pending completion of the City's pending recruitment for a full-term City Auditor; and


WHEREAS, the Audit Committee, having been consulted regarding the appointment of Mr. Elser, unanimously concurs with the Mayor's appointment of Kyle Elser as Interim City

Auditor and recommends his salary during the interim appointment be set at the FY2019 salary budgeted for the City Auditor and in accordance with the adopted FY2019 Salary Ordinance; and

WHEREAS, under Charter section 280(a)(6) the Council's confirmation of the City Auditor is not subject to veto by the Mayor; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council confirms the Mayor's appointment of Kyle Elser to serve as Interim City Auditor effective October 1, 2018, to serve in such capacity until the appointment of a full-term City Auditor, to occur upon completion of the pending recruitment process, with salary during the interim appointment as provided in the FY2019 budget for the City Auditor and consistent with the FY2019 Salary Ordinance.

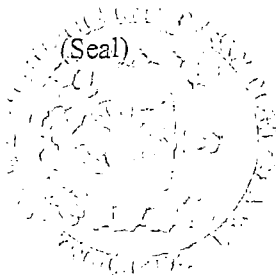
