A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING THE GOALS FOR THE CITY OF SAN DIEGO U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT PROGRAMS FIVE YEAR CONSOLIDATED PLAN FOR FISCAL YEARS 2020 - 2024.

WHEREAS, the City of San Diego (City) is an entitlement jurisdiction that annually receives federal funds through four U.S. Department of Housing and Urban Development (HUD) housing and community development entitlement programs: Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), Emergency Solutions Grants (ESG), and Housing Opportunities for Persons with AIDS (HOPWA) (collectively, HUD Programs); and

WHEREAS, HUD requires the City to prepare a Consolidated Plan (Plan) every five (5) years in order to receive federal housing and community development funding pursuant to the HUD Programs; and

WHEREAS, the purposes of the Plan include (1) identifying the City's housing and community development needs, priorities and goals; (2) identifying other federal, state, county, local and private sources of funding; and (3) establishing a strategic plan for the City to address such needs, priorities, and goals while considering the availability of other resources and mechanisms; and

WHEREAS, the City is required to prepare a new Plan for fiscal years 2020 - 2024 that must be submitted to HUD for review and approval on or before May 15, 2019; and

WHEREAS, the City is developing its Plan for fiscal years 2020 - 2024 in consultation with the intended primary beneficiaries of the HUD Programs, the community, adjoining jurisdictions, and non-profit, for-profit and faith-based community organizations; and

WHEREAS, the process of developing the City's Plan for fiscal years 2020 - 2024 includes assessing community needs, setting goals and developing strategies to address priority needs and objectives; and

WHEREAS, the goals and objectives established in the Plan for fiscal years 2020 - 2024 will direct the funding for the HUD Programs for fiscal years 2020 - 2024; and

WHEREAS, the City Council must approve the goals for the Plan for fiscal years 2020 - 2024 to direct completion of the Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following goals are adopted for the City's Plan for fiscal years 2020 - 2024:

- 1. Increase and preserve affordable rental and homeowner housing to improve access to housing opportunities that reflect community needs, including but not limited to, opportunities in close proximity to transit, employment, and community services.
- 2. Enhance the City's economic stability by investing in inclusive economic growth initiatives that develop and strengthen small businesses and support local entrepreneurs.
- 3. Foster individual and household resiliency by investing in employment and workforce development programs and improving access to job opportunities.
- 4. Support the development of vibrant, equitable, and adaptable neighborhoods by investing in public facilities and critical infrastructure.

- 5. Assist individuals and families to gain stable housing after experiencing homelessness or a housing crisis by providing appropriate housing and service solutions grounded in best practices.
- 6. Invest in community services that promote equity and serve vulnerable populations including, but not limited to, refugees and recent immigrants, previously incarcerated individuals, veterans, youth, seniors, and food insecure households.
- 7. Finance impactful nonprofit facility improvements to provide new or increased access to programs that serve vulnerable populations or implement sustainability measures.
