A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT WITH THE COUNTY OF SAN DIEGO TO BE THE ALTERNATIVE GRANTEE FOR ADMINISTRATION OF THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS ENTITLEMENT GRANT PROGRAM.

WHEREAS, the City of San Diego (City) is an entitlement jurisdiction that annually receives federal funds through the U.S. Department of Housing and Urban Development (HUD) Housing Opportunities for Persons with AIDS (HOPWA) entitlement grant program; and

WHEREAS, the County of San Diego (County) has directly received the HOPWA grant funds allocated to the City and administered these funds for the City pursuant to an agreement between the City and County dated August 11, 1998 (HOPWA Contract), authorized by City Council Resolution R-290511; and

WHEREAS, the City and County desire that the County continue to plan, coordinate, operate, administer, implement, and receive the HOPWA funds allocated to the City directly from HUD in fiscal years 2020 - 2024; and

WHEREAS, effective July 29, 2016, the Housing Opportunity Through Modernization Act (HOTMA) authorizes HUD to award HOPWA funds to an alternative grantee (Alternative Grantee), upon the request of the City; and

WHEREAS, the request to award HOPWA funds to an Alternative Grantee must be based on a written agreement between the City and the Alternative Grantee addressing how the Alternative Grantee will act consistent with the City's comprehensive housing affordability

strategy approved by HUD in the City's five (5) year consolidated plan (Con Plan) for fiscal

years 2020 - 2024; and

WHEREAS, the Alternative Grantee agreement may not exceed ten (10) years; and

WHEREAS, the City and County intend to terminate the existing HOPWA Contract and

enter into a new agreement for the County to be the Alternative Grantee for the City's HOPWA

entitlement grant program for fiscal years 2020 - 2024 (HOPWA Agreement), consistent with the

City's Con Plan for fiscal years 2020 - 2024; and

WHEREAS, the County will administer the City's HOPWA entitlement grant program

and the City will have no responsibility for the administration or oversight of the City's HOPWA

entitlement grant program; and

WHEREAS, the City will submit the HOPWA Agreement to HUD for approval; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that:

1. The Mayor, or designee, on behalf of the City, is authorized to negotiate and enter

into a HOPWA Agreement with the County for fiscal years 2020 – 2024.

2. The Mayor, or designee, on behalf of the City is authorized to submit the HOPWA

Agreement to HUD for approval.
