A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE AMENDMENTS TO COUNCIL POLICY 000-40, MARKETING PARTNERSHIP POLICY.

WHEREAS, the original Marketing Partnerships Policy, Council Policy 000-40, was created in 1999: and

WHEREAS, Council Policy 000-40 is being updated to reflect current business practices and to incorporate recommended revisions by the County Grand Jury; and

WHEREAS, the Corporate Partnerships and Development Program was recently the subject of a County Grand Jury report filed June 4, 2018 titled, "City of San Diego Corporate Partnership Development Program"; and

WHEREAS, in their report, the County Grand Jury recommends that Council
Policy 000-40 be updated in the following ways: (1) to include in the definition of "marketing
partnership agreements" the different types of agreements, such as sponsorship, licensing, and
promotional agreements, that Corporate Partnerships and Development uses to facilitate
marketing partnerships; (2) to include updates to address tracking and reporting of partnership
benefits such as net revenues, in-kind values, and non-monetary benefits; (3) to include
disclosure of conflicts of interest; (4) to include a requirement that appropriate departments
should be responsible for documenting and keeping records of marketing partnership agreements
that do not fall directly under the purview of Corporate Partnerships and Development; and (5) to
include an updated reporting requirement to City Council; and

WHEREAS, the proposed amendments to Council Policy 000-40 address each of these recommendations from the County Grand Jury; and

WHEREAS, the Budget and Government Efficiency Committee reviewed the proposed Marketing Partnership Council Policy 000-40 at its September 20, 2018 meeting and voted unanimously to forward it to the full Council with a recommendation to adopt the proposed amendments to the Council Policy; and NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the amendments to Council Policy 000-40 titled "Marketing Partnership Policy" are approved and adopted, and incorporated into existing Council Policy 000-40.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to update the Council Policy Manual to reflect this amended Council Policy.
