DATE OF FINAL PASSAGE OCT 10 2018

A RESOLUTION OF THE CITY OF SAN DIEGO APPROVING INCREASES IN THE CITY'S NON-EXCLUSIVE SOLID WASTE COLLECTION FRANCHISE FEES, EFFECTIVE JULY 1, 2019.

WHEREAS, by Resolution No. R-297887 adopted on April 28, 2003, the City Council established franchise fees for Class I and Class II Franchises of the City's Non-Exclusive Solid Waste Management Franchise System; and

WHEREAS, on May 4, 2009, by Resolution No. R-304850, the City Council raised the solid waste franchise fee to \$15.00 per ton for Class I Franchises and to \$16.00 per ton for Class II Franchisees; and

WHEREAS, economic indicators justify a further increase in the franchise fees; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that effective July 1, 2019, the franchise fee for Class I Franchises of the City's Non-Exclusive Solid Waste Management Franchise System is increased by \$1.00 per ton, to a new fee of \$16.00 per ton; and the franchise fee for Class II Franchisees of the City's Non-Exclusive Solid Waste Management Franchise System is increased by \$1.00 per ton, to a new fee of \$17.00 per ton.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that effective July 1, 2022, the franchise fee for Class I Franchises of the City's Non-Exclusive Solid Waste Management Franchise System is increased by \$1.00 per ton, to a new fee of \$17.00 per ton; and the franchise fee for Class II Franchisees of the City's Non-Exclusive Solid Waste Management Franchise System is increased by \$1.00 per ton, to a new fee of \$18.00 per ton.

BE IT FURTHER RESOLVED, that this activity is not a project as defined by the California Environmental Quality Act section 21065 and State CEQA Guidelines section 15378(b)(5), as it is an organizational or administrative activity of government that will not result in direct or indirect physical changes in the environment and therefore this activity is not subject to CEQA, pursuant to section 15060(c)(3).
