A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ADOPTION OF THE WATER SUPPLY ASSESSMENT FOR THE SAN DIEGO INTERNATIONAL AIRPORT DEVELOPMENT PLAN PROJECT TO FULFILL THE REQUIREMENTS OF CALIFORNIA STATE WATER CODE SECTION 10910.

WHEREAS, a Water Supply Assessment (WSA) was performed for the San Diego International Airport Development Plan Project (Project) to comply with the requirements of California Senate Bill 610 (S.B. 610), ratified by California State Water Code section 10910; and

WHEREAS, a WSA evaluates water supplies that are, or will be, available during normal, single dry year, and multiple-dry water years during a 20-year projection to meet the projected demands of the Project in addition to existing and planned future water demands of the Public Utilities Department (PUD); and

WHEREAS, the WSA was completed by PUD in compliance with the requirements under S.B. 610 and in consultation with the City of San Diego Development Services Department, the San Diego County Water Authority (Water Authority) and the Metropolitan Water District of Southern California (MWD); and

WHEREAS, the proposed Project consists of 661 acres located northwest of downtown San Diego on the San Diego Bay known as the San Diego International Airport and is in accordance with the San Diego County Regional Airport Authority's next master planning phase in a new Airport Development Plan; and

WHEREAS, the Project includes the demolition of 1,011,500 square feet of existing buildings as well as surface elements (parking lots, roadways and taxiways), and the construction of 5,252,806 square feet of new buildings and new surface elements; and

WHEREAS, the WSA demonstrates that there will be sufficient water supplies available during normal, single-dry year, and multiple-dry water years over 20-years to meet the projected level of water demand for this Project in consideration of regional water resource planning documents of the City, Water Authority, and MWD; and

WHEREAS, the estimated water demands for the Project are 597,402 gallons per day (GPD), or 669.2 acre-feet per year (AFY), and in the City's 2015 Urban Water Management Plan (UWMP), the planned water demand for this project is 235,440 GPD (263.7 AFY) in 2040; and

WHEREAS, as such, the remaining portion of the estimated demand, calculated to be 361,962 GPD (405.5 AFY), is accounted for through the Accelerated Forecast Growth demand increment of the Water Authority's 2015 UWMP; and

WHEREAS, based on the findings from the City's 2015 UWMP and the Water Authority's 2015 UWMP, the Project will result in no unanticipated demands; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to adopt the Water Supply Assessment for the San Diego International Airport Development Plan Project to fulfill the requirements of California State Water Code section 10910.
