A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF THE WATER SUPPLY ASSESSMENT FOR THE SAN DIEGO INTERNATIONAL AIRPORT DEVELOPMENT PLAN PROJECT IS STATUTORILY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15061(b)(3).

WHEREAS, the Water Supply Assessment (WSA) for the San Diego International Airport Development Plan (Project), which includes the demolition of 1,011,500 square feet of existing buildings (including administrative offices, cargo handling and maintence buildings and portions of Terminal 1) as well as surface elements (parking lots, roadways and taxiways), and the construction of 5,252,806 square feet of new buildings (terminal 1 gates, ramp control tower, administrative offices, utility plant expansion) and new surface elements, will increase terminal area and surface elements to meet increasing future passenger demands; and

WHEREAS, the California State Legislature, through the California Environmental Quality Act (CEQA) (California Public Resources Code sections 21000-21177), has determined that CEQA does not apply to various types of projects listed therein; and

WHEREAS, CEQA section 21084 states that the CEQA Guidelines shall list those classes of Projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15260-15285 list the statutory exemptions promulgated by the California State Legislature; and

WHEREAS, the Development Services Department has established that the Project is statutorily exempt from CEQA pursuant to CEQA Guidelines section 15061(b)(3); and

WHEREAS, the Council of the City of San Diego (City Council) has considered the potential environmental effects of the Project, and

WHEREAS, on OCT 09 2018, the City Council held a duly noticed public meeting and considered the written record for the Project as well as any public comment; and

WHEREAS, the City Council, using its independent judgment, has determined that the Project will not have a significant effect because of the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment; and

WHEREAS, approval of this City action does not constitute approval of a Project; approval of the Project for which this WSA has been prepared will occur in accordance with CEQA section 15004, which provides direction to lead agencies on the appropriate timing for environmental review; and

WHEREAS, this action will not foreclose review of alternatives or mitigation measures by the public as part of the CEQA process being conducted by San Diego County Regional Airport Authority as Lead Agency under CEQA for the San Diego International Airport Development Plan Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Project is statutorily exempt from CEQA pursuant to CEQA Guidelines section 15061(b)(3).

BE IT FURTHER RESOLVED, that the City Clerk is directed to file a Notice of Exemption regarding the Project with the Clerk of the Board of Supervisors for the County of San Diego.
