A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING FIRST AMENDMENTS TO AS-NEEDED CONSULTANT AGREEMENTS WITH DYETT & BHATIA, RRM DESIGN GROUP, AND PLACEWORKS, INC., FOR PLANNING SERVICES, AND TAKING RELATED ACTIONS.

That the Mayor, or his designee, is authorized to execute the First Amendment to the Dyett & Bhatia agreement for as-needed planning services (Contract No. H156342), in an amount not to exceed \$2,500,000, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 2. That the Mayor, or his designee, is authorized to execute the First Amendment to the RRM Design Group agreement for as-needed planning services (Contract No. H156343), in an amount not to exceed \$2,500,000, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the Mayor, or his designee, is authorized to execute the First Amendment to the PlaceWorks, Inc. agreement for as-needed planning services (Contract No. H156345), in an amount not to exceed \$2,500,000, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

4. That the Chief Financial Officer, or his designee, is authorized to expend an					
amount not to exceed \$7,500,000 for the purpose of executing the three aforementioned First					
Amendments to the as-needed planning services agreements.
