A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING FIRST AMENDMENTS TO AS-NEEDED CONSULTANT AGREEMENTS WITH DYETT & BHATIA, RRM DESIGN GROUP, AND PLACEWORKS, INC., FOR PLANNING SERVICES, AND TAKING RELATED ACTIONS.

WHEREAS, on May 26, 2015, pursuant to Resolution No. R-309678, the City Council authorized the execution of agreements for as-needed planning services with Dyett & Bhatia, RRM Design Group, and Placeworks, Inc., each in the amount of \$2,125,000, respectively contract numbers H156342, H156343, and H156345; and

WHEREAS, the Planning Department desires to execute first amendments to those three agreements, in the amount of \$2,500,000 each; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego as follows:

1. That the Mayor, or his designee, is authorized to execute the First Amendment to the Dyett & Bhatia agreement for as-needed planning services (Contract No. H156342), in an amount not to exceed \$2,500,000, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
2. That the Mayor, or his designee, is authorized to execute the First Amendment to the RRM Design Group agreement for as-needed planning services (Contract No. H156343), in an amount not to exceed \$2,500,000, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the Mayor, or his designee, is authorized to execute the First Amendment to the PlaceWorks, Inc. agreement for as-needed planning services (Contract No. H156345), in an amount not to exceed \$2,500,000, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

4. That the Chief Financial Officer, or his designee, is authorized to expend an amount not to exceed \$7,500,000 for the purpose of executing the three aforementioned First Amendments to the as-needed planning services agreements.

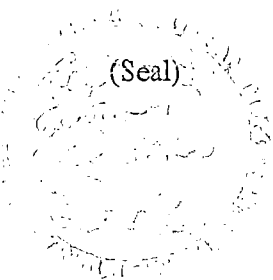
