BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to execute the First Amendment to the Agreement with Consultant for the Airport Master Plan studies in an additional amount not to exceed \$613,010 for a total amount not to exceed \$2,371,396 under the terms and conditions set forth in the First Amendment to Agreement on file in the Office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the Chief Financial Officer as delegated to Financial Management is authorized to appropriate and the City Comptroller is authorized to expend an additional amount not to exceed \$613,010 for a total amount not to exceed \$2,371,396 over five (5) years for the purpose of funding the consultant agreement with Consultant, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and

contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
