A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REDESIGNATING CITY-OWNED PROPERTY LOCATED AT THE WESTERLY END OF AVENIDA DE PORTUGAL STREET, IDENTIFIED AS ASSESSOR'S PARCEL NUMBERS 531-260-02, 531-260-17, AND 531-260-18 FOR PARKS AND RECREATION DEPARTMENT USE.

WHEREAS, on July 20, 1981, the Council of the City of San Diego (Council) designated the City-owned real property known as site number 440, located at the westerly end of Avenida de Portugal Street, identified as Assessor's Parcel Numbers (APN) 531-260-02, 531-260-17, and 531-260-18 (Property) for street purposes pursuant to San Diego Resolution R-254669 (July 20, 1981); and

WHEREAS, the Council reserved the right to change the designation or use of the Property at any time; and

WHEREAS, the City desires to use the Property to construct a neighborhood park, which will be known as Canon Street Pocket Park; and

WHEREAS, Planning Department staff has determined that the activity of re-designating the property for Parks and Recreation Department use is an organization or administrative activity of government that will not result in direct or indirect physical changes in the environment, and therefore is not a project pursuant to the California Environmental Quality Act (CEQA) Guidelines section 15378(b)(5), and that this action does not constitute approval of a project pursuant to CEQA Guidelines section 15352(a); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Property is re-designated for Parks and Recreation Department's use.

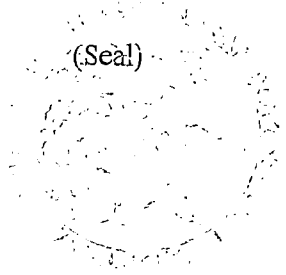
