DATE OF FINAL PASSAGE OCT 26 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT TO THE
COMMUNITY REVIEW BOARD ON POLICE PRACTICES.

WHEREAS, San Diego Charter section 43(d) gives the Mayor and City Council exclusive authority to establish a Community Review Board on Police Practices to review and evaluate citizens' complaints against members of the San Diego Police Department and the San Diego Police Department's administration of discipline arising from such complaints; and

WHEREAS, a Citizens' Review Board on Police Practices has been established and in existence since 1988; and

WHEREAS, through a ballot measure on the November 2016 ballot, voters amended Charter section 43(d) to: (1) extend authority from the Mayor alone to both the Mayor and City Council to establish a Community Review Board on Police Practices and to promulgate rules and regulations necessary for its operation; (2) change the name of the Citizens' Review Board on Police Practices to the Community Review Board on Police Practices, and (3) require that all police officer-involved shootings and in-custody deaths be reviewed by the Community Review Board on Police Practices; and

WHEREAS, San Diego Ordinance O-20961 amends the Municipal Code to reflect the changes approved by the voters, and will become effective not less than 30 days after its final passage on July 20, 2018 under Charter section 295(d); and

WHEREAS, the Board now consists of twenty-three members appointed by the Mayor and confirmed by the Council, who serve two-year terms, and until a successor is duly appointed and qualified; and


WHEREAS, Members of the Board may serve a maximum of eight consecutive years, and after after eight consecutive years of service, an interval of two years must pass before a member is eligible to be reappointed; and

WHEREAS, Members of the Board shall be appointed to staggered terms so that the terms of not more than twelve members shall expire in any year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments and reappointments by the Mayor of the City of San Diego, to serve as members of the Community Review Board, for terms beginning on the effective date of O-20961 and expiring as indicated, are made and hereby confirmed:

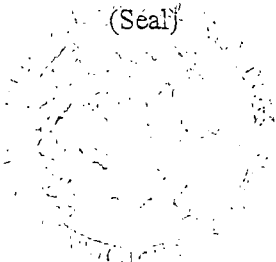
