A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE EXECUTION OF A COOPERATIVE PROCUREMENT CONTRACT AND RELATED MASTER LEASE AGREEMENT AND ADDENDUM, FOR THE PROVISION OF MULTI-FUNCTION COPIERS, PRINTERS AND EQUIPMENT APPLICABLE TO SCANNED DATA & MANAGEMENT, IMAGE DUPLICATING, AND RELATED SOLUTIONS, SUPPLIES AND SERVICES.

WHEREAS, in December 2017, the City of San Diego (City) issued, and in February 2018 received final responses to, a Request for Information which was designed to assist in determining the best model to follow for procuring multi-function devices, including copiers and printers and, as a result, determined that the City's requirements were similar to those of other government entities and could best be met through a cooperative procurement; and

WHEREAS, on October 19, 2016, after a national Request for Proposal (RFP) process, Sourcewell (formally known as the National Joint Powers Agency or NJPA), a service cooperative created by the Minnesota legislature as a local unit of government, awarded to Sharp Electronics Corporation a contract identified as Contract # 083116-SEC, for Multi-Function Copiers, Printers, and Equipment Applicable to Scanned Data & Management, Image Duplicating, and Related Solutions, Accessories, Supplies, and Services (NJPA Agreement); and

WHEREAS, the NJPA Agreement allows equipment to be leased through a Master Lease

Agreement with De Lage Landen Financial Services; and

WHEREAS, the City desires to piggyback on the NJPA Agreement and enter into a

Cooperative Procurement Contract with Sharp Electronics Corporation (Contract) and a related

Master Lease Agreement with De Lage Landen Financial Services; and

WHEREAS, as provided for in Section 22.3208 of the San Diego Municipal Code, the City's Purchasing Agent certified in writing that use of the NJPA Agreement was in the City's best interests, to the City's economic advantage, and the agency's contract was awarded using a process that complies with the City's policies, rules, and regulations and, pursuant to AR 35.11, the City's Purchasing Agent also approved in writing a five-year term for the Contract;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the Contract between the City of San Diego and Sharp Electronics Corporation for Multi-Function Copiers, Printers, and Equipment Applicable to Scanned Data & Management, Image Duplicating, and Related Solutions, Accessories, Supplies, and Services pursuant to the terms and conditions contained in the Cooperative Procurement Contract on file with the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the Master Lease Agreement between the City and De Lage Landen Financial Services pursuant to the terms and conditions contained in the Master Lease Agreement on file with the City Clerk as Document No. RR-____312025-2, and the Master Lease Agreement Addendum on file with the City Clerk as Document No. RR-____312025-3, and any subsequent leases pursuant to the Master Lease.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$6,380,000 over the full term of the Contract and the Master Lease, including any options to renew, contingent upon the adoption of the Annual Appropriation

Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
