A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN STATE FARM GENERAL INSURANCE COMPANY AND THE CITY OF SAN DIEGO.

WHEREAS, State Farm General Insurance Company filed a complaint against the City of San Diego (City) for inverse condemnation as a subrogation action following a water main break near their insured's property located at 4062 Oregon Street, San Diego, CA on January 5, 2017, which resulted in property damage; and

WHEREAS, on September 11, 2018, the City Council by the following votes: Yeas, Districts 1, 2, 3, 4,5, 6, 8, 9; Nays, None; and Absent, 7, approved the settlement of the claim for an amount consistent with the amounts set forth below; NOW THEREFORE

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

- 1. Authorizes the Mayor or his designee to pay the sum of \$95,000.00 from Water Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the inverse condemnation claim filed by State Farm General Insurance Company.
- 2. Authorizes the Chief Financial Officer to expend \$95,000.00 from Water Fund No. 700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
