A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO REPEALING COUNCIL POLICY 000-25
RELATING TO RECORDS MANAGEMENT.

WHEREAS, pursuant to Council Policy 000-01, the San Diego City Council (Council) is charged with the responsibility to establish municipal policies to guide the various functions of the City of San Diego (City); and

WHEREAS, by San Diego Resolution R-250975, adopted by the Council on January 14, 1980, the Council adopted Council Policy 000-25, Records Management Program; and

WHEREAS, by San Diego Resolution R-258594, adopted by Council on June 6, 1983, the Council amended Council Policy 000-25, and it has not been updated since that time; and

WHEREAS, by San Diego Ordinance O-20960, adopted by the Council on July 21, 2018, the Council approved updates to the San Diego Municipal Code (Municipal Code) relating to records management; and

WHEREAS, by San Diego Resolution R-311820, adopted by the Council on July 21, 2018, the Council approved updates to the City of San Diego City Clerk Administrative Guidelines (the Guidelines) relating to records management; and


WHEREAS, certain requirements previously referenced in Council Policy 000-25 are now detailed in the Municipal Code and the Guidelines; and

WHEREAS, staff proposes repealing Council Policy 000-25, Records Management Program, to be consistent with the Municipal Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Council Policy 000-25 is hereby repealed.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to update the Council Policy Manual to reflect the repeal of Council Policy 000-25.

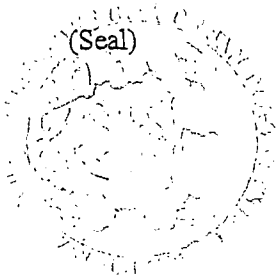
