A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING ELEVEN PUBLIC WORKS EMERGENCY SOLE SOURCE CONTRACTS.

WHEREAS, in Fiscal Year 2018 the City initiated eleven emergency sole source contracts to provide repairs to failures that included electrical, mechanical, sewer, water, and storm drain systems; and

WHEREAS, this action requests ratification of those emergency contracts that have been substantially completed to date; and

WHEREAS, San Diego Municipal Code (SDMC) section 22.3108 provides that public works contracts may be awarded without advertisement and competition when the public interest or necessity demands the immediate expenditure of public money to safeguard life, health, or property due to extraordinary fire, flood, storm, epidemic, or other disaster, provided that the Mayor immediately reports the emergency award and its justifications to the City Council in writing, and the City Council ratifies the award by resolution of a two-thirds vote; and

WHEREAS, in accordance with SDMC section 22.3108, for each emergency contract identified, the Public Works Department issued a memorandum notifying the City Council of the emergency condition at issue and certifying that the contract was necessary to perform the applicable emergency maintenance and repairs; and

WHEREAS, ratification of these emergency contracts requires a resolution passed by a two-thirds vote of the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the City Council, as follows:

That the City Council hereby ratifies eleven public works emergency sole source contracts as listed in Attachment A, which is on file in the Office of the City Clerk as Document No R312053
