BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, an eighth extension to the Agreement with Allan Company for the operation of the Miramar Landfill Recycling Center, retroactive to January 1, 2018, under the terms and conditions set forth in the Eighth Amendment
