DATE OF FINAL PASSAGE DEC 12 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN INCREASE TO EXPENDITURE AUTHORITY FOR THE AGREEMENT WITH CALMAT CO. DBA VULCAN MATERIALS COMPANY WESTERN DIVISION TO PROVIDE ASPHALT CONCRETE ON AN AS-NEEDED BASIS.

WHEREAS, the City's Street Division within the Transportation & Storm Water Department performs maintenance services for existing streets such as filling potholes and other types of asphalt repairs. Asphalt concrete (asphalt) is also used to temporarily patch sidewalk defects to mitigate potential tripping hazards; and

WHEREAS, Street Division also constructs public works projects, such as asphalt overlays and installation of curb ramps and center medians, which require restoration of asphalt pavement after completion of the improvements; and


WHEREAS, Street Division has a Service Level Agreement (SLA) with the Public Utilities Department (PUD) for restoration of trenches after repair of water and sewer main breaks. As part of this SLA, Street Division performs approximately 200,000 square feet of asphalt trench repairs annually; and

WHEREAS, the competitively-bid Agreement with Calmat Co. dba Vulcan Materials Company Western Division (Vulcan) for asphalt on an as-needed basis was executed in July 2017, per San Diego Municipal Code section 22.3206, which allows the Purchasing Agent to enter into contracts up to \$3.0 million, with the intent to bring the contract back to City Council for approval of the full expenditure authority; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor or designee is authorized to increase the expenditure authority of the agreement with Vulcan for the remaining term of the contract, for a total not to exceed contract amount of \$12,424,906 over five years.

BE IT FURTHER RESOLVED, that the expenditure of the funds is contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and sufficient funding being available in each participating City departments' budget each fiscal year.
