A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF AN ASNEEDED AGREEMENT WITH DIAMOND CONCRETE SUPPLY FOR READY MIX CONCRETE DELIVERY.

WHEREAS, the Street Division within the Transportation & Storm Water Department performs maintenance services utilizing ready mix concrete for existing concrete streets and alleys, raised medians, curbs, sidewalks, and cross gutters, with repairs consisting of removing and replacing damaged concrete; and

WHEREAS, Street Division also has a Service Level Agreement (SLA) with the Public Utilities Department (PUD) for restoration of concrete streets, alleys, and sidewalks after repair of water and sewer main breaks. As part of this SLA, Street Division performs approximately 36,000 square feet of repair of sidewalks, concrete streets, cross gutters, and alleys annually. In addition, PUD uses ready mix concrete for minor repairs, such as those required following trenching or other repairs to the City's water system; and

WHEREAS, in April 2018, the City issued Invitation to Bid (ITB) No. 10089093-18-K for the delivery and pumping of ready-mixed concrete on an as-needed basis. The solicitation was publicly advertised, posted on PlanetBids, and Purchasing & Contracting staff conducted outreached to potential bidders. Diamond Concrete Supply was the lowest responsive and reliable bidder; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee, is authorized to execute an agreement with Diamond Concrete Supply, Inc. for an amount not to exceed \$9,516,310 over the five-year term of the contract.

BE IT FURTHER RESOLVED, that the expenditure of the funds is contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and sufficient funding being available in each participating City departments' budget each fiscal year.
