A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE EXECUTION OF THE
COOPERATIVE AGREEMENT WITH CALTRANS FOR
CONSTRUCTION OF BIKE IMPROVEMENTS AT I-5/SR56.

WHEREAS, the City of San Diego and the California Department of Transportation (Caltrans) will partner to complete the missing westerly segment of the State Route 56 Bike Path; and

WHEREAS, the State Route 56 Bike Path is a 10.5 mile closed multi-use pathway parallel to State Route 56, that provides an efficient back and forth pathway to connect communities between Interstate 5 (I-5) and Interstate 15 (I-15) and to provide a safe corridor for pedestrians and cyclists; and

WHEREAS, at its current configuration starting from the eastern most street (Rancho Carmel Drive) and heading west, the bike path ends at a dirt path approximately 200 feet from Interstate 5. The proposed project would extend the current bike path and go underneath I-5 (Bridge #57-390) at which it will connect to the Old Sorrento Valley Road (Coastal Rail Trail and I-5 North Coastal Trail); and


WHEREAS, to help fund this project, the City will contribute up to \$2,250,000 for the construction. Caltrans will be responsible for the remaining financial obligations and completion of the project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute a Cooperative Agreement with Caltrans for construction of bicycle improvements connecting the west end of the SR 56 Bike Path to Old Sorrento Valley

Road (Coastal Rail Trail and I-5 North Coastal Bike Trail), passing under I-5 south of Carmel Creek Bridge (Bridge #57-390).

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend \$2,250,000, from CIP S00982, Interstate 5 Underpass-Bikeway/Ped Conn, for funding the Cooperative Agreement with Caltrans to construct the bike project. Of the \$2,250,000, \$1,630,229 is from Carmel Valley Consolidated FBA Fund, Fund Number 400088, and \$619,771 is from Carmel Valley DIF Fund Number 400855.
