A RESOLUTION DECLARING THE RESULTS OF THE MUNICIPAL GENERAL ELECTION AND THE MUNICIPAL SPECIAL ELECTION HELD IN THE CITY OF SAN DIEGO ON NOVEMBER 6, 2018

WHEREAS, a Municipal General Election was held in the City of San Diego on Tuesday, November 6, 2018, pursuant to the provisions of Ordinance No. O-20962 (New Series), introduced and adopted on July 17, 2018, for the purpose of electing candidates to the offices of Councilmember for Districts 2, 4, 6, and 8, respectively; and

WHEREAS, a Municipal Special Election was held in the City of San Diego on Tuesday, November 6, 2018, pursuant to the provisions of Ordinance No. O-20963 (New Series), introduced and adopted on July 17, 2018, for the purpose of submitting ballot measures to the qualified voters of the City of San Diego (including one ballot measure submitted, pursuant to the California Constitution, only to the qualified voters of the San Diego Unified School District), with the ballot measures described as follows:

- One citizens' initiative measure regarding the Mission Valley Stadium Soccer
 City Initiative (Measure E).
- One citizens' initiative measure regarding the Mission Valley Stadium SDSU
 West Initiative (Measure G).
- One measure (submitted only to the qualified voters of the San Diego Unified School District) regarding whether to amend the San Diego City Charter (City Charter) related to enacting term limits for members of the San Diego Unified School District Board of Education (Measure H).

- 4) One measure regarding whether to amend the City Charter related to the mandatory disclosure of business interests related to City contracts (Measure J).
- One measure regarding whether to amend the City Charter related to limiting City Councilmembers to serving two four-year terms. (Measure K).
- One measure regarding whether to amend the City Charter related to ethics and compensation for elected City officers (Measure L).
- 7) One measure regarding whether to amend the City Charter related to the reappointment of Audit Committee public members (Measure M).
- 8) One measure regarding whether to reinstate an industrial disability retirement benefit for San Diego police officers (Measure N).

WHEREAS, the measures, as stated in the ordinances placing them on the ballot, are:

MEASURE E. MISSION VALLEY STADIUM – SOCCER CITY INITIATIVE: Shall the City lease Mission Valley stadium property and the San Diego Chargers practice facility on Murphy Canyon Road to a private party for 99 years, with an option to buy some stadium property, consistent with price, terms, and conditions described in the measure; and adopt a specific plan and agreement allowing development of stadium, river park, recreational, residential, office, hotel, retail and other uses; and amend related land use laws? MEASURE G. MISSION VALLEY STADIUM – SDSU WEST INITIATIVE: Shall the City sell Mission Valley stadium property to San Diego State University or any SDSU auxiliary organization, entity, or affiliate, consistent with price, terms, and conditions described in the measure, to	YES

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the Municipal General Election and Municipal Special Election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of this election has been completed and the City Clerk has certified the results to the City Council; and

WHEREAS, declaring the results of the election as certified by the Registrar of Voters and the City Clerk is a ministerial act required by California Elections Code section 10263 and, therefore, is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.0411 of the San Diego Municipal Code, as follows:

I

The City of San Diego had 761,959 registered voters eligible to vote in the November 6, 2018 election. The total number of votes cast in the City for various Citywide ballot measures ranged from a low of 415,208 votes to a high of 466,281 votes. The total number of votes cast in the San Diego Unified School District for Measure H, which was submitted only to School District voters pursuant to the California Constitution, was 333,005.
