A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AND RATIFYING A SIDE LETTER AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND THE SAN DIEGO MUNICIPAL EMPLOYEES ASSOCIATION RELATED TO DOWNTOWN PARKING.

WHEREAS, by San Diego Resolution R-310148 (December 16, 2015), the San Diego City Council (Council) approved and ratified a Memorandum of Understanding between the City of San Diego (City) and the San Diego Municipal Employees Association (MEA), setting forth the terms and conditions of employment for MEA-represented employees for Fiscal Years 2017 through 2020 (MOU); and

WHEREAS, Articles 38 and 53 of the MOU provide employees with certain parking benefits at the Concourse Parkade and Civic Center Plaza through Transportation Programs and Transportation Incentives; and

WHEREAS, in approving the Fiscal Year 2018 Salary Ordinance on April 25, 2017

(San Diego Ordinance O-20817), the Council authorized the Mayor to implement additional parking discounts for City employees, who work downtown, in accordance with terms negotiated between the City and its recognized employee organizations and approved by the Council; and

WHEREAS, the City has been evaluating other downtown parking locations to accommodate City employees; and

WHEREAS, the City has met and conferred with MEA and reached an agreement to amend Articles 38 and 53 of the MOU to cover parking at 101 Ash Street, the Central Library, Horton Plaza, and other facilities designated by the Mayor, under the same terms and conditions as parking at the Concourse Parkade and Civic Center Plaza; and

WHEREAS, this Side Letter Agreement has been negotiated pursuant to the Meyers-Milias-Brown Act (MMBA) and Council Policy 300-06 and is subject to Council approval to take effect; and

WHEREAS, the Side Letter Agreement must be approved by a two-thirds majority vote of this Council, in accordance with San Diego Charter section 11.2; and

WHEREAS, the Council desires to approve and ratify the Side Letter Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to the MMBA and Council Policy 300-06, the Council approves and ratifies the Side Letter Agreement between the City and MEA, related to downtown parking, on file in the Office of the City Clerk as Document No X/-312133
