A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING ADDITONAL DOWNTOWN PARKING BENEFITS FOR UNREPRESENTED EMPLOYEES

WHERERAS, City employees who park at the Concourse Parkade or Civic Center Plaza receive certain parking discounts; and

WHEREAS, in approving the Fiscal Year 2018 Salary Ordinance on April 25, 2017 (San Diego Ordinance O-20817), the Council authorized the Mayor to implement additional parking discounts for City employees, including unrepresented employees, who work downtown, in accordance with terms negotiated between the City and its recognized employee organizations and approved by the Council; and

WHEREAS, the City has been evaluating other downtown parking locations to accommodate City employees; and

WHEREAS, the City has met and conferred with its recognized employee organizations and reached agreements with each of them to cover parking at 101 Ash Street, the Central Library, Horton Plaza, and other facilities designated by the Mayor under the same terms and conditions as parking at the Concourse Parkade and Civic Center Plaza; and

WHEREAS, pursuant to the Fiscal Year 2018 Salary Ordinance, the City wishes to extend these negotiated parking benefits to unrepresented employees; and

WHEREAS, the Council desires to approve the extension of the negotiated parking benefits to unrepresented employees; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council approves the extension of the negotiated parking benefits to unrepresented employees.
