## RESOLUTION NUMBER R- 312151 DATE OF FINAL PASSAGE DEC 1 3 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CALLING A PUBLIC HEARING TO DETERMINE WHETHER THE PUBLIC HEALTH, SAFETY OR GENERAL WELFARE REQUIRES THE FORMATION OF UNDERGROUND UTILITY DISTRICTS IN RESIDENTIAL BLOCKS IN UNIVERSITY CITY (1S), MISSION BEACH (2S3), KENSINGTON (3AA), TERALTA (3AA1), NORMAL HEIGHTS (3BB, 3BB2), ENCANTO (4R1), CLAIREMONT MESA (6K, 6K2), ALLIED GARDENS (7R1) AND DEL CERRO (7U).

WHEREAS, Chapter VI, Article 1, Division 5 of the San Diego Municipal Code establishes a procedure for the creation of underground utility districts and requires as an initial step in such procedure the holding of a public hearing to determine whether the public health, safety or general welfare requires removal of poles, overhead wires and associated structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service in any such district; and

WHEREAS, Council Policy 600-8, "Underground Conversion of Utility Lines by Utility Company" further governs the undergrounding of utilities; and

WHEREAS, in accordance with Chapter VI, Article 1, Division 5 of the San Diego Municipal Code and Council Policy 600-8, it has been recommended that the following underground utility districts (District) be formed:

- 1S (UU232) University City
- 2S3 (UU981) Mission Beach
- 3AA (UU915) Kensington
- 3AA1 (UU213) Teralta
- 3BB (UU909) Normal Heights
- 3BB2 (UU912) Normal Heights
- 4R1 (UU899) Encanto
- 6K (UU499) Clairemont Mesa
- 6K2 (UU858) Clairemont Mesa

- 7R1 (UU970) Allied Gardens
- 7U (UU949) Del Cerro

The legal descriptions of each District listed above are on file in the Office of the City Clerk as Document No. RR- 312151; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. Notice is hereby given that a public hearing will be held by the Council of the City of San Diego on <a href="Tuesday">Tuesday</a>, <a href="January 29">January 29</a>, <a href="Zeo Batthe">Zeo Batthe</a> hour of <a href="Zeo Dem">Zeo Dem</a> in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, to determine whether the public health, safety or general welfare requires the removal of poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service in the Districts described above.
- 2. At such hearing all persons interested shall be given an opportunity to be heard and said hearing may be continued from time to time as may be determined by the City Council. The decision of the City Council as to the formation of the District as described above shall be final and conclusive.
- The City Clerk shall notify all affected persons as defined in Chapter VI,
   Article 1, Division 5 of the San Diego Municipal Code and each utility company concerned of
