A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING APPOINTMENTS OF COUNCILMEMBERS TO STANDING COMMITTEES FOR CALENDAR YEAR 2019

WHEREAS, Rule 6.1 of the Rules of Council, San Diego Municipal Code (Municipal Code) section 22.0101, provides for specific standing committees of the San Diego City Council (City Council); and

WHEREAS, Rule 6.2.1 provides that the Council President shall, no later than the second meeting of the Council in January of each year, nominate the committee chair, vice-chair, and committee members, subject to confirmation by a majority vote of the City Council; and

WHEREAS, Council President Georgette Gomez has submitted nominations for the committee chairs, vice-chairs, and committee members for specific standing committees of the City Council for calendar year 2019, and now seeks City Council confirmation of the appointments detailed in this resolution; and

WHEREAS, the additional appointments of Councilmembers to serve on the City's Audit Committee, which is governed by the City Charter, and to serve as Council President Pro Tem will be considered by the City Council in separate actions and are not included in this resolution; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,
